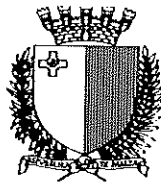

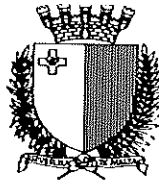

The Commission confirmed your ineligibility for the following reasons:

The Qualifications that you presented were not sufficient because the Diploma in Good Practice in Child Care and Education was at Level 3.

Although you were in possession of the top up course, you did not have the Diploma for Children & Young persons. Additionally, the Diploma facilitating in Inclusive Education was not considered as a relevant qualification. Furthermore you were not in possession of the Diploma in Early Education and Care MQF level 4 and therefore you were deemed as ineligible.

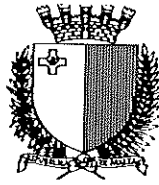
Illi jidher illi l-problema principali kienet li l-livell tad-Diploma tar-rikorrenti f'Level 3 ma kienx sufficjenti peress illi kellu jkun Level 4. Dan, ir-rikorrenti, ghamlitu car mill-bidu nett kif jidher fit-talba taghha u r-risposta li tat ghat-twegiba tal-email ta' Corinne Grech .

It-Tribunal ghalhekk jidhirlu li jekk kien hemm xi tort jew malintiz, dan sar min-naha ta' Rita Agius illi minghajr ebda rizervi, kawtela jew domandi, qaltilha mal-ewwel 'You can apply for the Top Up Course'. Ghalhekk meta s-socjeta' intimata tghid illi l-izball sar minhabba li r-rikorrenti applikat ghal KGA Level II mentri l-kwalifiki taghha kienu biss ghal supply Kindergarten Assistant, dan bl-ebda mod ma gie ppruvat.
